Extension of paid parking in Scheveningen Geuzen- en Statenkwartier

# Why is paid parking necessary?

There are increasingly more cars in the city. Parking space is scarce, especially in older neighbourhoods. The growing parking nuisance that this causes leads to unsafe situations and makes it difficult for the emergency services, people in wheelchairs or people with baby strollers to get where they need to go.

The Municipality of The Hague is addressing this problem; on 30 November, paid parking is being introduced in your neighbourhood. This will allow you to find a parking spot more quickly close to your home/business. This will also improve the liveability and accessibility of this part of the city. Perhaps you do not experience parking nuisance in your street at the moment.

To avoid the so-called waterbed effect, the Statenkwartier will also be made part of the area in which paid parking is in force. If we did not take this measure, parking nuisance there would increase drastically.

# What does this mean for you?

If you have a car and are not able to park on your own property, you can buy a parking permit. To be able to allow your visitors to park close to your home, you can apply for a visitors' permit. Paid parking comes into effect on 30 November 2017.

Parking regulations will apply in the entire permit area between 13.00 hrs and 24.00 hrs. They will apply in Frederik Hendriklaan and Aert van der Goesstraat as well. The parking regulations will therefore change there. With a parking permit valid for this area, you will be able to park in the entire permit area. Note! The parking permits will not apply in the shopping streets during business hours from 13.00 hrs to 18.00 hrs Monday to Saturday.

#### Parking for residents

With a parking permit, you will be able to park you own car at a reduced rate. This applies to public roads in the Geuzen-Statenkwartier permit area. You qualify for a permit if you live at an address in Geuzen-Statenkwartier.

- are not yet registered and will be living in Geuzen- Statenkwartier;
- have a second home in Geuzen- Statenkwartier;
- share a car.

Note! You do not automatically qualify for a residential parking permit.

Do you have a parking space on your own property? \*

In that case, you can only apply for a residential parking permit for your second or further car. The rate for the first residential permit then applies to your second car ( $\mathfrak{C}$ 36.60 a year).

#### **Parking for visitors**

Residents can apply for a visitors' parking permit. This permit will allow your visitors to park without paying. The visitors' parking permit will give you 223 hours' parking credit and is valid for one permit year. The permit year runs from 1 October to 1 October. You can apply for one visitors' parking permit per household. Multiple visitors can park at the same time.

Visitors can also pay for parking by:

- checking in via a mobile telephone when they arrive and checking out again when they leave. They then only pay for the time they were actually parked there.
- paying at the parking meter.

You enter the car's registration number.

## Parking for informal caregivers

Do you receive informal care?

Then you may qualify for a parking permit for informal caregivers. Go to the website for further information and for the conditions.

#### Parking for companies and institutional establishments

Companies with an address in Geuzen-Statenkwartier qualify for a company parking permit. You are entitled to one parking permit for every five fulltime employees. If your company is located at your home address (work/business space), the first permit is a residential parking permit.

Multiple businesses registered at the same address are regarded as one company.

# Note! You do not automatically qualify for a company parking permit.

Do you have a parking space on your own property? \*

The number of company parking permits that can be issued is reduced by the number of parking spaces on the own property.

- \* Parking space on own property is understood to include:
- · A parking space on a property or in a garage, owned or rented; or
- That you have at your disposal a parking space on the property, or in the garage of a complex, belonging with the address of the applicant.

#### **Preparation**

In preparation of switching to paid parking, certain adjustments are being done to the streets. Where parking situations are unclear, for example, extra signs will be placed to make it clear whether you may or may not park at a particular spot.
